OP, I think you should also consult a lawyer (Student Legal Service seems the obvious choice; they are familiar with Suburban Express and its activities). The university hasn't done anything about this issue till now, but now the Suburban Express guy is defacing public/university property and using university resources like noticeboards in campus buildings to harass and intimidate students. This should be reported to someone in the university administration, though I am not sure who is the correct person. UIUC has a duty to protect its students from harassment, and not be passive and refuse to do anything because they fear lawsuits.

I would have suggested ISS too, but after their lip-service-only performance last time ("we will write to the Attorney General" - something from which nothing ever materialized), I don't know if approaching them will be worth your time.

If a prospective undergraduate/graduate student or faculty were visiting, and saw those flyers, it wouldn't reflect well on the university. This is much more hurtful to the university's image than the ads he keeps posting in classrooms and noticeboards despite being told not to. It is high time the university at least acknowledges this menace, and imposes sanctions on him and his company's operations on campus.

Their response - which I got second-hand - was that they would need a massive increase in funding just to support the counties around Champaign. I remember something like 50% being thrown around, to account for more lawyers, staff, travel and lodging, etc., and you would need approval from the University Board of Trustees to allow service outside of Champaign County. If that's something people want, ISS can push for it. Just know that it'll take years to accomplish.

Various members of ISS (including myself) have spoken with an Associate Dean of Students, the Vice-Chancellor for Student Affairs, and the Chancellor, but the administration is unwilling or unable to go beyond letting Student Legal Services offer unofficial advice and help students find discount/pro bono representation. The unspoken feeling seems to be that Suburban Express hasn't done anything illegal or against University rules - that can be proved - yet, and that going after them more directly would expose the University to litigation.

To go item by item:

Draft a letter to the Chancellor requesting a reply

The Chancellor is aware of the issue (though perhaps not the reinstatements) and seems content to allow the Vice-Chancellor for Student Affairs to handle the matter for now (see the above text).

"Invite" a Dean to an ISS meeting to speak about what he/she thinks the school should plan to do about this...to hold them accountable. Then, you can question the Dean's actions, or lack there of.

The relevant Dean here would be the Dean of Students. ISS honestly should have him to more meetings to talk on the record, but ISS usually directs questions for the Dean and his office to the Associate Dean who serves as our advisor.

Contact news agencies on behalf of the ISS

The Student Body President or Vice-President can speak for ISS and the Student Body officially, and ISS has a dedicated reporter from the Daily Illini. The press will continue to report what they feel is news worthy, not what ISS asks them to cover.

FIGHT for student rights/protections

ISS does fight for your rights and protection. Members of ISS campaign for fair student loan practices, leniency for non-violent offenses, "good samaritan" protections, fairness in academic integrity hearings, upkeep for emergency systems on campus, and more. Their legal threats to Murph aside, Suburban Express has only tried to enforce the contracts riders agreed to - odious and legally flawed as they may be. As of right now, helping students build defenses and find attorneys is all the University's legal counsel is like to approve - and thus all that's likely to get done. If you could get thousands of students and parents to rally on the Quad in support of stronger action or more funding for Student Legal Services, maybe that would change things.

The ISS should demand an investigation.

If OP files a police report and asks us to help, I'm sure ISS would call on the University PD to investigate. Those cameras exist for a reason after all.

I would really like to know what the ISS actually does. Granted I don't follow ISS' activities very closely, but from what I recall from reading the Daily Illini and on reddit, they seem to spend a lot of money (paid from student tuition) on useless stuff like freebies on Quad Day and on cupcakes; the iclicker rental is the only productive thing I have heard that the ISS did, and I don't know how much it benefits students compared to the money that goes into keeping ISS running.

Of course, the ways in which the ISS serves the student body need not all be financial, but your "we can't do anything, our hands are tied, we spoke to the university administration but they didn't listen" attitude makes you sound wimpy and ineffectual. If something doesn't have a direct, easy solution, you can't do it - that's the impression I get. Why would anyone approach the ISS at all if all it took was speaking to a Dean about a direct solution - they could do it themselves then, with no need to get the ISS involved.

The only reason Suburban Express couldn't bully us when this all started was because of the moderator's personal courage - he refused to take down the banner when he, a mere student, could

face a lawsuit while protecting the rights of what is effectively an online forum he moderates as a volunteer, and you are saying that a well-funded organization like the ISS is unwilling to risk that? And once he acted courageously, help started flowing in, in the form of support from Popehat, computer forensics experts, etc.

Also, I am concerned about whether ISS senators are well-coordinated and kept well-informed, since you seemed unaware of the proposed letter from ISS to the Attorney General. I would expect as a senator you read the Daily Illini, at least the parts that pertain to ISS, and would be aware of what the other senators are saying to the press.

I would really like to know what the ISS actually does.

The ISS doesn't get a whole lot of publicity, in part because the majority of our business is neither exciting or controversial (e.g. nominating advisory committees for the administration, reviewing proposals to change degrees or open research centers, discussing upgrades to campus IT infrastructure...) and in part because outreach is aimed at Facebook and our tiny, crippled listserv. (I created /r/ilstudentsenate last year so senators could post resolutions, committee reports, and updates on what they're personally working on, but I'm one or maybe four reddit users in ISS (out of 54) and it never took off. Maybe next year...) I'll try to

make an itemized list of "everything" ISS does and post it later, but I'd recommend coming to a meeting or two. They're not very thrilling, but it's where stuff comes together between

the many committees and the Faculty-Student Senate.

Financially, ISS spends most of the money it allocates on cosponsoring awareness or spirit events (e.g. bicycle safety, suicide prevention, UIUC's birthday, Quad Day, homecoming...), though we have made some very bad fund allocations in the past. The actual running of ISS is pretty cheap compared to most units on campus. We have no paid staff (some universities actually pay their student representatives) and only a few fixed expenses: two phone lines the University mandates we lease, office supplies, and some misc. IT costs. An associate Dean from the Office of the Dean of Students acts as our advisor, but I'm not sure she's actually paid for it (which is pretty sad).

you are saying that and a well-funded organization like the ISS is unwilling to risk that?

Yes. The ISS doesn't control its own accounts or its legal representation - the University does. Everything beyond what the University's already done would have to come from our own pockets and at our personal risk. Murph's got a lot of courage, but it also helps to have the law firmly behind you.

About as well coordinated and informed as any group I suppose. I'd imagine how "informed" a senator is on a given

issue trends with how much they're involved with what's being said or done. Maybe President Bolden told us about his letter to the Attorney General during his weekly report to the Senate, maybe I read about it in the DI. (I at least skim it every day.) Most likely, I just forgot about it.
