I then spoke with Robert Frazier, the owner of Bright Ideas, and he stated that he has received several notices from Illinois Power about the power bill. Robert stated that the power bill was about \$1000.00 and he paid \$800.00 of it. Robert said that when Illinois Power came today to shut off his power he told the man (Jason Brown) that he would go to the bank and get the other \$200.00 and pay him. Robert stated that Jason told him that he does not take money and that he would have to shut the power off. Robert said that he contacted Illinois Power and he was told that the decision was up to the Illinois Power employee at the scene. Robert said that he told Jason that he needs power to run his business.

Robert stated that a little later his power went off. Robert said that he became very angry and may have threatened to shoot and kill Jason but he did not mean it. Robert said that after he made the threat, he then went into the back room to try to get his power generator to work. Robert stated that he has no weapons in the business and was only mad when he made the comment.



I then spoke with David Daniel, who works at Bright Ideas, and I asked him what he heard and saw. David said that he goes by "Scott" and after the power was shut off by the Illinois Power man, Robert said, "Scott, you might as well call the cops before I shoot and kill this guy. David said that Robert was referring to the Illinois Power employee (Jason Brown). David stated that Jason was only doing his job and did nothing to Robert to provoke such a threat. I asked David if there were weapons in the business and he said he didn't think so.

I then spoke with Christy Lazzell, who also works at Bright Ideas, and she stated that she was upstairs in her office when the power went off. Christy stated that she then went downstairs to see what was going on she heard Robert say something to the effect of, "get this guy the hell out before I shoot the son of a bitch". Christy stated that Robert was referring to the Illinois Power man who shut the power off.

I then placed Robert Frazier under arrest for assault and I transported him to the county jail.

After I cleared the jail I was informed that another witness was waiting to speak with me at the Sheriff's Office.

I spoke with witness Mac McClure, who is with the Illinois Department of Revenue, and he said that he was talking business with Robert Frazier when the power went out. Mac stated that Robert said that he was going to shoot and kill that son of a bitch for shutting off his power. Mac said that the Illinois Power employee stood up and asked Robert what he said and Robert told him that he was going to shoot and kill him. Mac stated that the Illinois Power employee was visibly scared after he heard that statement. Mac said that he told Robert that he was going to leave because he didn't know what was going to happen and he didn't want to get shot. Mac stated that he then left the business. Mac stated that he was so shocked by Robert's threat that he wanted to come in and give his statement.

On 7-17-02 at 1206 hours I was dispatched to Bright Ideas, 4400 W. Springfield, in Champaign for threats in progress. Metcad informed me that somebody is threatening to shoot and kill somebody at the business.

Upon arrival I spoke with RP/Victim, Jason Brown, who works for Illinois Power. Jason stated that the power bill was over due at Bright Ideas so he went there to shut the power off. Jason said that before he shut the power off he spoke to the owner, Robert Frazier, and advised him of the situation. Jason said that he told Robert what he was going to do, but if Robert paid the bill he could have the power turned back on in a short amount of time. Jason said that Robert wanted to talk to his supervisor so Robert called Illinois Power. Jason stated that Robert got upset because he got put on hold so he hung up. Jason stated that Robert told him that he would get the money and pay the bill right away and Jason said that he would talk to his supervisor. Jason said that he went outside and called his supervisor and he was told that Bright Ideas have had enough warnings and to go ahead and shut off the power.

Jason stated that he went inside the business to the power meter and cut off the power to the business. Jason said that Robert got very angry and said, "I'm going to shoot and kill you before you leave the front door". Jason stated that Robert then went into another room. Jason said that he feared for his safety because he thought that Robert was going to get a gun. Jason stated that he then went outside and called the police and his supervisor.

While speaking with Jason I could tell he was visibly shaken and upset.
